Rationale:

The Lymph System and Bowenwork gives you first an overview of the lymphatic system and the amazing congruency between how that system needs to be addressed, and the way we approach the body in our own work. Knowledge of the lymph system anchors and gives credence to what we say about the mechanics of the Bowenwork move. You will understand the rationales and specific tactics for the order of moves and procedures to optimize lymph flow, as well as additional mechanisms that should be considered when working with persons with lymphatic issues.

Course Aims and Outcomes:

At the end of this class, you will be able to

- demonstrate a basic understanding of the lymphatic system
- identify Bowenwork procedures that support the lymphatic system
- demonstrate good form for performing procedures with appropriate tension and pressure
- identify the differences between edema and lymphedema
- demonstrate an understanding of the value of the Bowenwork home remedies in supporting the lymphatic system in client self-management
- demonstrate proficiency in the client interview process with regard to lymphatic complaints
- understand the limits of what we can do with lymphedema, and when we might choose to refer a client out
- compare the development, progression, and characteristics of lymphedema with conditions that might be mistaken for it
